From the Bay Area or Sacramento: Eastbound I-80 to Northbound CA-65 (Lincoln). CA-65 to Sunset Blvd. Turn left (west) and proceed until Sunset Blvd. dead ends at Foothills Blvd North. Turn right (north) at Foothills Blvd North and proceed until dead end at Athens Ave. Turn left (west) at Athens Ave. and proceed until dead end at Fiddymment Rd. Turn right (north) at Fiddymment Rd. (The field is on the right approximately 1 and ½ miles from this point.)
